As we head into the fall and winter months, there are a few updates we want to share with you about the progress of our remediation project related to our Fire Technology Center.

Town of Peshtigo Supervisors Pass Resolution to Move Forward with Exploring Marinette as Source of Drinking Water

As reported in the *EagleHerald* on October 23, a resolution was passed by the Town of Peshtigo Board of Supervisors on October 20 to begin exploring solutions with the City of Marinette to begin providing water to Town of Peshtigo residents in the impacted area. Tyco appreciates the Town of Peshtigo Supervisors continued attention to this matter, and we will continue to work with leaders to ensure residents have clean drinking water.

Fish Testing Results

We've sent out fish samples taken from private ponds in the investigation area to a new laboratory for further testing. Preliminary testing of the fish was inconclusive because the results were clouded by the presence of non-PFAS compounds in the fish tissue, similar to how static interferes with listeners hearing music being played on the radio. The second laboratory will attempt to filter out the interference, and we expect results from them by early November.

Deer Hunting Advisory

Tyco understands the importance of deer hunting to our community and wants to make sure you have the information you need for this season.

The Wisconsin Dept. of Natural Resources (WDNR) tested the PFAS levels in deer from the area around the Tyco Fire Technology Center in Marinette. Based on their results, the Wisconsin Dept. of Health Services and WDNR shared the following information on deer in the 5-mile area shown below:

As a long-time part of this community, Tyco continues to make donations to benefit its residents.

\$1.3 Million Donation to Marinette

The Marinette City Council recently voted to accept Tyco's offer to donate \$1.3 million to buy equipment that will allow the City to more easily and effectively dispose of biosolids from its wastewater treatment facility. This donation was in addition to the \$3 million we gave to the City for the testing, removal, treatment and disposal of biosolids from its holding tanks last year. As Marinette Mayor Steve Genisot said in a statement about the most recent donation, "We appreciate Tyco's \$1.3 million financial donation, which allows the city to address this important issue."

Donation of 12,000 Fire Extinguishers to Local Families

Last year, there was a heartbreaking house fire in Oconto County that took the lives of a family with ties to Tyco. Recognizing that the company has a responsibility as a global fire protection business and leading employer in the region, our employees came together ahead of Fire Protection Month in October to look at actions we could take to reduce some of the risk of a similar tragedy in the future. This month, Tyco started to distribute fire extinguishers to the families of students in 26 schools within Marinette, Menominee and Oconto Counties.
