## Potential Payment for Increase in Real Estate Taxes and Water Charges if Areas of PWSA Are Annexed to City Of Marinette

\* If annexation is pursued by residents and is successful, Tyco would provide an upfront, one-time payment to property owners in the annexed area that would be calculated using the net present value (NPV) of 20 years of increased property taxes and water bills, based on current home assessment values, tax rates, and average water bills. This is in addition to paying for the construction of the water line.

## SAMPLE CALCULATIONS FOR DEVELOPED PROPERTIES

We calculated the increase in property taxes per parcel by using the increase in 2021 property taxes and applying an assumed rate of annual increase (2.5%) to the 2021 number over 20 years.

We took the additional cost for the water fee in 2021 (estimated \$480/year) and calculated what that amount would be for each of the 20 years using an assumed annual increase (3%) for the water fee.

We added together the increase in property taxes and the water fee (both adjusted for annual increases) for each of the 20 years, and we discounted the total of those costs for each year to present value based on an assumed discount rate (3.15%). This is the net present value presented on the spreadsheet.

The formula for any one year of the calculation is set forth below:

Future Value of Water Fee =  $W = 480 \text{ x} (1+r_w)^n$ 

Future Value of Property Tax Increase = P = 2021 Increase x  $(1+r_p)^n$ 

**Present Value of P** + W = (P+W) x  $(\frac{1}{(1+r_a)^n})$
